

CIRCLE F DUDE RANCH CAMP AGREEMENT
Must be filled out by campers & parent(s) or guardian(s)

The following guidelines are designed to ensure that camp is a happy, safe, and productive community for everyone. Read them carefully. If you have any questions, please contact us immediately.

- 1) Our policy does not allow campers to smoke at camp. The possession or use of illegal drugs or alcohol is not permitted at camp and will result in immediate dismissal with no refund.
- 2) Leaving camp property other than with parent(s) or guardian(s) is not permitted.
- 3) Campers are expected to be present at all scheduled activities and to remain in supervised areas at all times.
- 4) Cabins are private and open to residents only. Campers may enter a cabin other than their own only with permission of the residents of that cabin. Co-ed visitation in cabins is not allowed.
- 5) Leaving cabins after lights-out in the evening is prohibited except in the event of medical necessity.
- 6) Physical and/or verbal hostilities are not permitted while at Circle F Dude Ranch. Respect towards other campers as well as counselors is expected.
- 7) Sexual harassment, verbal sexual harassment, or sexual contact is inappropriate to the community and is not permitted. Offenders will be dealt with and may be asked to leave camp without refund.
- 8) Circle F Dude Ranch is not responsible for valuables kept in cabins. Money, plane tickets, and other valuables must be locked in the office at the start of camp. Campers must respect property of others. Raids of theft or property will not be tolerated.
- 9) It is imperative that Horseback Riding, Waterfront, and Rock Climbing/Zipline Rules be understood and followed by everyone. Rules will be explained and/or posted in appropriate locations.
- 10) Weapons, knives, matches, fireworks, and any other potentially dangerous items are not to be brought to camp.
- 11) All medication, prescription or non-prescription (including aspirin), must be kept in the infirmary at all times. There are only a few exceptions such as asthma inhalers, epi kits, etc. If in doubt, please ask.
- 12) Respect for all living things is expected. Wildlife, camp animals, and the natural environment are to be protected. Destructive behavior is not permitted.
- 13) Each member of the camp community is expected to contribute to keeping the cabins and camp property clean and maintained. Graffiti or any other form of vandalism is strictly prohibited.
- 14) Campers shall return home with no physical alterations to their bodies or hair, i.e. hair dying, cutting, and shaving are not allowed. Likewise, any form of body piercing or permanent tattooing is forbidden.
- 15) Campers are not permitted to bring cellular phones to camp and are asked to leave them at home.

I understand that there will be no reduction or refund of fees for campers sent home for behavioral problems, homesickness, habitual bed-wetting, or non-adjustment to the camping experience or for late arrivals or early departures. I further understand that there is no refund available for discontinuation of the camp season due to acts of God, Natural disaster, Acts of War or Epidemics. I also hereby release the use of photo/video images and work product of the above registered camper for the purpose of camp promotion and display to the general public.
